Instagram photography competition, July 2017

Full Terms and Conditions

1. Information on how to enter form part of the terms and conditions of entry. Entry into the competition is deemed acceptance of these terms and conditions.
2. The promoter is Grimshaw Architects Pty Ltd, ABN 40 124 418 364, 21 Bouverie Street, Melbourne VIC Australia 3053, ph +61 (3) 9321 2600.
3. Employees and their immediate families of Grimshaw Architects Pty Ltd and their agencies and companies associated with the promotion are ineligible to enter the competition.
4. The competition commences at 12.00am (AEST) Monday, 3 July 2017 and closes at 11.59pm (AEST), Monday, 31 July 2017.
5. How to enter:
Step 1: Download the Instagram application for iPhone or Android
Step 2: Take and edit your photo
Step 3: Upload the photo to Instagram with the tags @grimshawarch and #scssnap2017 (Instagram privacy settings must be set to 'public' for Grimshaw Architects Pty Ltd to retrieve your photo)
 - 5.1. Entrants are not permitted to use tripods or similar camera stands
 - 5.2. Anyone entering Southern Cross Station for the purposes of taking photographs is subject at all times to the directions and instructions of Station security personnel
6. Only entries submitted via the Instagram application and which are appropriately hashtagged will be accepted. Photographs submitted must be original works.
7. Grimshaw Architects Pty Ltd will shortlist no more than 100 entries, each of which will form part of the #scssnap2017 exhibition, to be held at Grimshaw Architects Pty Ltd's Melbourne studio from 17-23 August, 2017.
8. The promoter shall endeavour to contact and notify the shortlisted entries via their Instagram account by 5pm, Tuesday 1 August 2017 (AEST).
9. Individuals who receive notification that their image has been shortlisted must provide a high resolution jpg file of the image as directed, no later than 5pm, Friday 4 August 2017 (AEST). Failure to do so may result in images being printed directly from Instagram, at a lesser image quality.
10. Each image shortlisted for the #scssnap2017 exhibition will be printed as a 30cm x 30cm size image. As such it is recommended that the photographs are taken using a camera with 12 megapixels or more.
11. Judging will take place between Monday 7 August and Wednesday 9 August, 2017 (AEST) at Grimshaw Architects Pty Ltd's studio in Melbourne. If the winner is under the age of 18 years, the prize will be awarded to their parent or legal guardian.
12. The top three winners, and the winner of the People's Choice Award, must be able to collect their prize in person from Grimshaw's Melbourne studio, between 16 and 31 August 2017.
13. The competition is a game of skill, and chance plays no part in the selection of the winner. Submissions will be judged according to the following criteria:
 - 13.1 The relevance of the submitted photo to the theme in question, as decided by the judges.
 - 13.2 Artistic interpretation of the theme, as decided by the judges.

- 13.3 Originality of the submission. Entries that are deemed to not belong to or be taken by the user will not be eligible.
14. Judge's decision is final and no correspondence will be entered into. Prizes cannot be transferred. Non-cash prizes cannot be redeemed for cash.
 15. The promoter reserves the right to verify the validity of entries and to disqualify any entry which, in the opinion of the promoter, includes objectionable content, profanity, potentially insulting, inflammatory or defamatory statements, disqualify any entrant who tampers with the entry process, who submits an entry that is not in accordance with these terms and conditions of entry or who has, in the opinion of promoter, engaged in conduct in entering the promotion which is fraudulent, misleading, deceptive or generally damaging to the goodwill or reputation of the promotion and/or promoter. The promoter reserves the right to disqualify a winner if the promoter becomes aware that the winner and/or the winner's entry is of a type described in this clause.
 16. Entries must be received by 11.59pm (AEST) Monday 31 July 2017. The time of entry will in each case be the time the entry is received by Grimshaw Architects Pty Ltd. The promoter accepts no responsibility for any late, lost or misdirected entries due to technical disruptions, network congestion or for any other reason.
 17. The cost of accessing the promotional website will be dependent on the entrant's individual internet service provider.
 18. Use of images:
 - 18.1 All images published on Instagram with #scsnap2017 may be moderated and displayed on the website and social media channels of Grimshaw Architects Pty Ltd and its associated partners. These images and associated usernames will be public to all.
 - 18.2 By entering the competition and accepting the terms and conditions you agree that you hereby license the rights to use your photo submission to Grimshaw Architects Pty Ltd, its associated partners as well as Southern Cross Station Pty Ltd on any of its websites or social media channels, or for advertising and promotion of its products, services, and/or its company in any media now known or hereafter developed in perpetuity in exchange for no compensation of any kind.
 19. Use of personal information:
 - 19.1 By entering the competition and accepting the terms and conditions, you agree that Grimshaw Architects Pty Ltd may use your personal details for the purpose of conducting the competition, including the use of your Instagram name in promotional formats.
 - 19.2 By entering the competition, you give Grimshaw Architects Pty Ltd permission to contact you via Instagram if you are a winner of the competition for the purpose of distributing your prize to you.
 20. The promoter reserves the right to request winners to provide proof of identity and proof of residency at the nominated prize delivery address. Identification considered suitable for verification is at the discretion of the promoter.
 21. The promoter reserves the right to refuse to allow a winner to take part in any or all aspects of the prize, if the promoter determines, in their absolute discretion, that a winner is not in the mental or physical condition necessary to be able to safely participate in the prize.
